The Alabama Clean Fuels Coalition (ACFC) successfully applied to offer this 2021 summer internship opportunity. The Clean Cities University Workforce Development Program (CCUWDP) is funded through the Technology Integration Program within the Vehicle Technologies Office at the U.S. Department of Energy in collaboration with Argonne National Laboratory. 4. Create posts related to ACFC's objectives and upcoming events and activities to post on social media sites and ACFC's website.

5. Create informational posts that help to promote activities of ACFC and its members.

6. Schedule social media posts.

7. Participate and assist with scheduled promotional and educational events for AFVs and EVs taking place over the summer.
