This course introduces principles and practices of community health; it includes drug/alcohol use and abuse, communicable disease, cardiovascular disease, cancer, consumer health, health organizations and environmental concerns.

- 9. The student will identify resource organizations that help rehabilitate alcoholics.

- 11. The student will distinguish between over-the-counter drugs and prescription drugs.
- 12. The student will examine the impact drugs have on crime, medicine and society.

 - 6. The student will compare alternatives to standard medical treatment.
 - 7. The student will identify characteristics of quackery and fraud.
- D. The student will recognize major non-infectious health problems and identify methods of prevention and treatment.

Cardiovascular Disease

- 1. The student will evaluate the current status of heart disease in the United States.
 - 2. The student will identify and describe basic components and functions of the circulatory system.
 - 3. The student will list and/or discuss risk factors that predispose an individual to heart disease or stroke.
 - 4. The student will describe various treatments for heart disease including diagnostic tests, drugs, surgery, balloon angioplasty, lasers and transplants.

Cancer

- 1. The student will identify various carcinogenic factors.
- 2. The student will investigate the importance of early diagnosis of cancer using the seven warning signals as recognized by the American Cancer Society.
- 3. The student will describe the techniques of self-breast and testicular examinations as recommended by the National Cancer Institute.
- 4. The student will examine various forms of cancer.

Other Major Diseases

- 1. The student will examine various diseases.
