Core Area IV, ASCI TSCI (Lec 3 hrs)
- II. Course Description**  
This course surveys the background, constitutional principles, organization, and operation of the American political system. Topics include the U. S. Constitution, federalism, civil liberties, civil rights, political parties, interest groups, political campaigns, voting behavior, elections, the presidency, bureaucracy, Congress, and the justice system. Upon completion, students should be able to identify and explain relationships among the basic elements of American government and function as more informed participants of the American political system.

This course will provide a survey of the institutions of American Government, and analysis of the Constitution, the civil rights of its citizens, and the role of political parties and interest groups in campaigns and elections.

## **IX. Assessment of Instructional Effectiveness**

This section describes how student performance related to specific course objectives is used to assess instructional effectiveness in helping students meet Jefferson State's General Education Objectives. This section does not describe how course grades are determined.

The student will demonstrate knowledge of:

- A. The constitution and major institutions of American government
- B. The basic civil rights of its citizens
- C. The processes and problems of political campaigns and elections

### **General Education Objective**

The student will read, understand, and evaluate materials written at a variety of levels and for a variety of purposes. Student comprehension of this task will be measured by:

- A. Direct assessments: Student essays will be evaluated at the end of a term. Also, the performance of each student on multiple-choice tests will reflect the student's general knowledge of the organization of the American National Government.
- B. Indirect assessments: The student's participation in class discussion will contribute to the final grade in the course.
- C. Student evaluation: the student will evaluate the instructor's effectiveness

### **Use of Findings**

The instructor will modify his methodology based on student performance and evaluation and will discuss finding with colleagues as needed.

## **X. Attendance**

Students are expected to attend all classes for which they are registered. Students who are unable to attend class regularly, regardless of the reason or circumstance, should withdraw from that class before poor attendance interferes with the student's ability to achieve the objectives required in the course. Withdrawal from class can affect eligibility for federal financial aid.
