II. Course Description

This course builds upon basic skills in Web authoring. Various Web authoring tools are introduced. Upon completion students will be able to use these tools to enhance Web sites.

V. Course Objectives

- A. The student will understand the role of Web authoring environments in assembling complete Web sites.
- B. The student will be able to set up a complete Web site in a professional Web authoring environment.
- C. The student will utilize the Web authoring environment's tools to generate HTML and CSS syntax to accomplish specific goals for individual Web pages and the Web site as a whole.

VI. Course Outline of Topics

- A. The student will understand the role of Web authoring environments in assembling complete Web sites.
 1. The student will be able to explain the advantages of Web authoring environments.
 2. The student will be able to identify shortcomings in the code generated by Web authoring environments.
 3. The student will be able to balance the use of direct code editing with the code generation tools in a Web authoring environment.
- B. The student will be able to set up a complete Web site in a professional Web authoring environment.
 1. The student will be able to locate the commands necessary to establish a site within the Web authoring environment.

2. The student will be able to differentiate between various options offered when creating a new site within the Web authoring environment.
 3. The student will be able to place the new site in a desired location on a local or network storage device.
 4. The student will be able to establish a hierarchy of folders in the site from within the Web authoring environment.
 5. The student will be able to add and remove individual files of various types in an established site from within the Web authoring environment.
- C. The student will utilize the Web authoring environment's tools to generate HTML and CSS syntax to accomplish specific goals for individual Web page and the Web site as a whole.
1. The student will be able to apply basic formatting to text on a Web page.
 2. The student will be able to select from several different block tags within the Web authoring environment.
 3. The student will be able to insert hyperlinks onto a page, specifying the target and title attributes as the hyperlink is added.
 4. The student will be able to insert images onto a page, specifying properties as the image is added.
 5. The student will be able to insert form elements onto a page.
 6. The student will be able to create and modify a table.
 7. The student will be able to generate a page with an advanced layout using tables, frames, or CSS positioning tags.
 8. The student will be able to create, modify, and apply CSS styles for tags, identifiers, and classes.
 9. The student will be able to place CSS styles inline, as an embedded style, or in a separate style sheet file by making a selection within the Web authoring environment.
 10. The student will be able to manually edit the HTML and / or CSS code for a page within the Web authoring environment.

VII. Evaluation and Assessment

Evaluation and assessment will be determined by the instructor and specified on the instructor's class syllabus. Grades will be based upon following scale: A = 90 – 100%, B = 80 – 89%, C = 70 – 79%, D = 60 – 69%, and F = below 60%.

VIII. Attendance

Students are expected to attend all classes for which they are registered. Students who are unable to attend class regularly, regardless of the reason or circumstance, should withdraw from that class
