You will receive information about uniforms, malpractice insurance, background check, and drug testing on the first day of class. Malpractice insurance is purchased from the Jefferson State cashier's office.

3. Once we receive your electronic application and you meet the requirements to register for EMS classes, we will send you an email instructing you to register for your Summer 2025 EMS courses. Please note that you may need to register for additional courses if you are pursuing an associate of applied science degree in EMS. ### **Grant Funding for Tuition Available**

# **Emergency Medical Services Admission Information**

### Students Seeking admission into the EMS Program must:

- Be admitted to Jefferson State Community College
- Submit a completed EMS Application Packet by the scheduled deadline.
- Submit to a background check. Applicants with a history of criminal arrest or convictions should discuss the matter with the EMS Program Director or Clinical Coordinator for guidance. Failure to participate in the background check process will disqualify students from the EMS Program. Students who fall out of progression for any reason will be required to submit to additional background checks prior to performing clinical or field rotations.
- Meet all licensure requirements and essential functions for the EMT as described by the Alabama Department of Public Health, Office of EMS.

### Students entering or continuing the program at the AEMT level must meet the requirements above in addition to the following:

• Hold a current, unencumbered State of Alabama EMT license, current NREMT EMT certification, and current American Heart Association Basic Life Support certification.

**NOTE: Jefferson** State EMS Program students moving directly from EMT to AEMT may enroll in EMS 155 and EMS 156 before completing the above requirement. However, students must attain an Alabama EMT license prior to their first clinical rotation in EMS 156.

### Students entering or continuing the program at the Paramedic level must meet the requirements above in addition to the following:

- Provide proof of 1) qualifying ACT scores, 2) Official transcripts, or 3) placement test scores. Test scores must be within 5 years, and an official copy must be on file with Jefferson State's testing office. An unofficial copy must be submitted with the EMS Application Packet OR proof of completion of ENG 101 and MTH 100 or higher (MTH 116 not accepted).
- Students must have successfully completed EMS 155 and EMS 156 at Jefferson State Community College or completed an equivalent AEMT curriculum at another CoAEMSP accredited EMS program with a "C" average or higher **AND** have a current, valid Alabama EMT license.

#### -OR-

Hold a current, unencumbered State of Alabama AEMT license, a current NREMT AEMT certification, and a current American Heart Association Basic Life Support certification.

**NOTE:** Students that have completed an AEMT program at an educational institution that was not CoAEMSP accredited during the entire time of the student's attendance will be required to complete EMS 155 and EMS 156 before being admitted into the Paramedic Program.

### **General Information / Approximate Tuition and Fees**

Emergency Medical Services providers (EMSPs) are licensed medical professionals who provide emergency medical care to the sick and injured to promote health, alleviate suffering, and conserve human life. This exciting and fast paced field is rapidly growing, and EMSPs are in high demand. EMSPs in Alabama are licensed at three levels: EMT, AEMT, and Paramedic. Certification through the National Registry of EMTs is required to achieve Alabama licensure at each level. The costs listed below are estimates based on current tuition rates. Tuition is subject to change without notice.

Emergency Medical Technician (EMT) is designed for students wishing to begin their career in Emergency Medical Services. The EMT scope of practice includes bandaging and splinting, oxygen administration, patient assessment, hemorrhage control, placement of supraglottic airways, the use of an AED, as well as other skills. This course qualifies students to achieve certification and licensure as an EMT. EMTs generally work for fire departments and ambulance services. EMT training consists of one semester of classroom/lab work along with clinical rotations that occur both in the field and at hospitals.

Advanced Emergency Medical Technician (AEMT) is designed for students wishing to expand their career in Emergency Medical Services. The AEMT scope of practice includes everything in the EMT scope of practice plus the ability to initiate intravenous therapy, intraosseous access, and limited pharmacology. This course qualifies students to achieve certification and licensure as an AEMT. AEMTs generally work for fire departments and ambulance services. EMT training consists of one semester of classroom/lab work along with clinical rotations that occur both in the field and at hospitals.

Paramedics are professionals trained to treat injuries and illnesses in an out-of-hospital setting. Skills performed by Paramedics include everything in the AEMT scope of practice plus ECG interpretation, administration of multiple emergency medications, synchronized cardioversion, manual defibrillation, transcutaneous pacing, needle chest decompression, and advanced airway management procedures. Paramedic certification is required for critical care and flight paramedic programs, tactical paramedic certification, and community paramedic licensure. Paramedics are primarily employed by fire departments, ambulance companies, and in a variety of clinical and non-clinical roles. Paramedic training consists of three semesters of classroom and lab work along with clinical rotations that occur both in the field and at hospitals.

Our program offers a Short Certificate, Long Certificate, and an Associate of Applied Science (AAS) degree in EMS. Successful completion of the Paramedic Short Certificate requirements makes the student eligible to take the NREMT Paramedic certification exam. General education classes required for the Paramedic Long Certificate and the AAS in EMS may be taken concurrently with the Paramedic core courses. The Paramedic Short Certificate and Paramedic Long Certificate can be completed in 3 consecutive semesters, or 1 calendar year. Most students will need at least 1 additional semester to complete the AAS Degree in EMS.

Five additional courses (EMS 247, EMS 189/BIO 201, ENG 101, MTH 100, SPH 106/SPH 107) are required beyond the Paramedic Short Certificate to earn the Paramedic Long Certificate. Those 5 courses (15 credit hours) increase the total cost by approximately \$2,520 plus the cost of any required additional books or other course materials.

Three additional general education courses (BIO 103, PSY 200, humanities/fine arts elective) are required beyond the Paramedic Long Certificate to earn the AAS. Those additional three courses (10 credit hours) increase the total cost by approximately \$1,680 plus the cost of any required books or other course materials.

## Emergency Medical Services Additional Information

### **Licensure Requirements**

If you plan to apply for admission to the program (for any certificate level), you may be required to comply with additional licensure requirements at any level of EMSP (even if you are admitted to the program). There are specific certification requirements established by NREMT, and specific licensure requirements established by the Alabama Department of Public Health, Office of EMS. Areas that may prevent a student from becoming licensed include (and may not be limited to):

- Not being eighteen (18) years of age or older within one year of course completion date of the entry level course.
- Having been convicted of any criminal act, including but not limited to, driving under the influence (DUI) and felonies.
- Having previously been and/or currently being addicted to the use of intoxicating liquors or controlled substances.
- ❖ Failure to achieve emergency vehicle operations course (EVOC) certification.
- Not meeting the medical and physical minimum requirements as required by the Functional Job Analysis published by the U.S. Department of Transportation.
- Not possessing a valid driver's license.
- Not meeting other requirements of the Alabama EMS Rules (Alabama Administrative Code Chapter 420-2-1).

Additional information about licensure requirements for EMTs may be obtained from the National Registry of Emergency Medical Technicians at (614) 888-4484, or from the Office of EMS of the Alabama Department of Public Health at (334) 206-5383.

**NOTE:** The Alabama Infected Health Care Worker Management Act mandates that any health-care worker performing invasive procedures who is infected with human immunodeficiency virus (HIV), or hepatitis B virus shall notify the State Health Officer, or his designee, of the infection. To complete individual program certificates in the EMS program, you must

- Progress through the required courses for each program certificate in the prescribed sequence as published in this document.
- Complete all of the courses required in the EMS curriculum with a grade of "C" or higher.
- ❖ Maintain current American Heart Association Basic Life Support certification.
- Comply with all "Essential Functions" as published for the EMS program.
- Submit acceptable physical examinations at intervals not to exceed twelve (12) months.
- Maintain current professional liability, and health/hospitalization, accident insurance while enrolled in the program.
- Comply with all published policies, procedures, and rules for students from the College and all its cooperating health agencies.

### Jefferson State Community College Emergency Medical Services Program Student Health Requirements Checklist

Please complete all the requirements listed below. You may meet the requirement with *one* of the listed suggestions. All requirements must have documentation submitted to prove the fulfillment of the requirement. All requirements must be fulfilled prior to beginning clinical and field rotations.

### MMR (Measles/Rubeola, Mumps & Rubella):

- **I. Documentation of positive IgG titer for Measles/Rubeola, Mumps & Rubella. a.** If any of the titer results are NEGATIVE or EQUIVOCAL, the student must get the first MMR vaccination and provide proof of documentation. The second MMR vaccination must be completed after 28 days, and documentation submitted.
- **II.** Documentation of completion of one series of MMR immunizations. *One "series" of immunizations includes two immunizations for each disease on separate dates at least 28 days (4 weeks) apart.*

### VARICELLA (Chicken Pox)

- **I.** Documentation of positive IgG titer for Varicella. *Documentation of the history of the active disease is not sufficient.* **a.** If the titer result is NEGATIVE or EQUIVOCAL, the student must get the first Varicella vaccination and provide proof of documentation. The second Varicella vaccination must be completed 30 days later, and documentation submitted.
- **II.** Documentation of completion of one series of Varicella immunizations. *One "series" of immunizations includes two immunizations at least 30 days apart.*

### **Tetanus/Diphtheria/Pertussis (TDAP)**

**I.** Documentation of vaccination within last 10 years.

### Influenza Vaccine (Flu Shot)

- I. Documentation of current season immunization (Fall and Spring Semesters)
- II. Signed medical exemption form. This will require that the student wears a mask during the designated flu season.

### **Hepatitis B**

- **I.** Documentation of complete 3 shot series **OR** POSTIVE anti-HBs serologic testing.
- **II.** Students without proof of vaccination or immunity must receive the first and second dose of the vaccination and sign a waiver if the vaccination series is not complete prior to the start date of clinical rotations.

### **Tuberculosis (TB)**

**I.** Documentation of a negative TB skin test (PPD) within the last year. Must be renewed annually **a.** If TB skin test results are POSITIVE, documentation of a clear chest X-ray is required. If chest X-ray is Positive, student should have appropriate treatment and documentation.

### **Physical Examination**

**I.** Documentation of physical examination and EMS Essential Functions completed by a licensed healthcare provider. Form provided by EMS program. Examination and form must be completed within the last year. Must be renewed annually.

- **❖** Faxed, mailed, or hand delivered applications will not be accepted.
  - **Attendance** is mandatory for each of the first scheduled classes.
- \* Refunds are based on the first day of classes, not the first scheduled class meeting.
- **❖** All documents turned in as part of the application process become property of JSCC.

Applications are due Friday, January 9, 2026.

All academic holds must be cleared before students can register, and NO LATER than the first day of class.
